SCHEDULE "A" TO THE
DOG CONTROL FEES POLICY

1. Dog Control

a) License Fees

- For every dog:
 - Any breed \$20.00

Renewal License Applications - Received between January 1st and February 28th

- For every dog:
 - Any breed \$20.00

Renewal License Applications – Received between March 1st and December 31st

- For every dog:
 - Any breed \$30.00

b) Impounding and Redemption

On any first offense - the sum of FIFTY DOLLARS (**\$50.00**) plus TEN DOLLARS (**\$10.00**) for each day or any part thereof the dog has been impounded and in addition, a dog license, if applicable;

On any second offense occurring within the current license year - the sum of SEVENTY FIVE DOLLARS (**\$75.00**) plus TEN DOLLARS (**\$10.00**) for each day or any part thereof the dog has been impounded;

On any third or any subsequent offense occurring within the current license year - the sum of ONE HUNDRED DOLLARS (**\$100.00**) plus TEN DOLLARS (**\$10.00**) for each day or any part thereof the dog has been impounded.

The full amount of any costs incurred by the Municipality for the examination and treatment by a licensed veterinary surgeon of a dog that is injured or sick.

c) Disposal of Dogs Impounded

Full cost to dispose of (veterinarian costs) or other and any outstanding impoundment fees and fines.

d) Lost License Tags

Replacement of license tag is **\$5.00**.

e) Penalties and Fines

- General Penalties:

Every person who contravenes a section of this By-Law is guilty of an offense and where no other penalty is prescribed herein, then the penalty shall be as follows:

| - 1st Offense | Not less than \$25.00 per day plus costs |
| - 2nd Offense | Not less than \$50.00 per day plus costs |
| - 3rd or Subsequent Offenses | Not less than \$100.00 per day plus costs |

With said fines - Not to exceed \$1000.00 plus costs

f) Specific Offenses

- Permitting a dog to run at large:

| - 1st Offense | Minimum \$100.00 |
| - 2nd Offense | Minimum \$150.00 |
| - 3rd Offense | Minimum \$200.00 |

With said fines - Not to exceed \$1,00.00

- Failing to purchase a license \$20.00 plus license fee
- Interference or obstruction of Poundkeeper or any person authorized by Council shall have a fine of Minimum \$100.00 - Maximum \$1,000.00

g) Potentially Dangerous or Vicious Dogs

Anyone who keeps, owns, harbors or possesses a "POTENTIALLY DANGEROUS OR VICIOUS DOG" shall be liable to a minimum fine of \$200 not to exceed \$1,000.

h) All dog owners are responsible to remove excrement of one's dog from property other than owner's property within the Village limits.
